Two more new ships in the domestic fleet



Groupe Desgagnés has acquired a new Beluga F-240. It is a multi-purpose LO-LO vessel with tween decks, able to transport heavy loads. The vessel is over 138 meters long, has 20,000 m³ total freight capacity in its holds and main deck, and is equipped with two 120 mt cranes which may be deployed to lift 240 mt in tandem. Named the **Rosaire A. Desgagnés**, it is rated Ice Class 1A and will be operated primarily in the eastern Canadian Arctic to serve northern communities. This \$40 million investment is an excellent example of a dedicated SSS vessel.

Ocean Group continues it launch with the arrival of its second new tug in less than three months. The **Ocean Henry Bain** is an ultramodern 5,000 (BHP) tug. It is powered by two omnidirectional Z-Drive engines, has a Class 1 fire-control system and is rated Ice Class 1A.The new acquisition will be assigned to Quebec port operations and will also be used for escorting other vessels, short- and long-distance towing, search operations, and wreck recovery. This will make marine services on the St. Lawrence even better!



Highway H₂O continues its public awareness campaign

It is impossible not to notice to the efforts made by Highway H₂O to attract new cargo to the St. Lawrence - Great Lakes system. For the past few years, promotional campaigns have been put forward to raise awareness among the public, such as shippers, of the benefits of marine transportation. All these initiatives are innovative and original. The most recent, "Blue is Green" specifically emphasizes the environmental benefits of marine transportation.

Comprised of the St. Lawrence River, St. Lawrence Seaway and the Great Lakes, Highway H₂O is a 3,700-kilometer (2,400 mile) marine highway that runs between

Canada and the United States. Hwy H2O flows directly into our commercial, industrial and agricultural heartland, home to some 100 million people, roughly one quarter of the Canada/U.S. combined population.

The numbers speak for themselves:

- the value of goods transported by water in North America is valued at over \$300 billion annually.
- maritime commerce on Hwy H2O annually generates more than \$4.3 billion in personal income, \$3.4 billion in transportation-related revenue and \$1.3 billion in federal, state and local taxes.
- waterborne shipping is the mode of transport for 3/4 of the planet's international trade.

Highway H2O can carry more than double the volume it is currently transporting, while the roads that serve the same axis are already above capacity, and the public investments required are enormous. Why ignore this potential when everyone is talking about sustainable development?

Action Plan on Climate Change: Québec's Transportation Measures

The Government of Quebec's action plan on climate change includes tow measures that affect cargo transportation and will be managed by Transport Quebec as of 2007-2008. A \$10 million annual budget will support initiatives to promote intermodal projects (including increased use of railways and shipping in domestic and continental transport). This funding will be made available through a new component of the Assistance Program for Modal Integration (APMI). In addition, \$5 million per year will be made available to business submitting projects to introduce technological innovations in the area of energy efficiency in road, rail, or marine transport. These two funding programs should be available through 2012.
