After a near two-year break, during which time the Feasibility Study on Marine Cargo Transport to the North Shore was completed, the Quebec Shortsea Shipping Council started up again last December. The Council currently has 15 members—some long-standing, others new—thereby offering a diverse yet comprehensive range of expertise.

Coordinated by the St. Lawrence Shipoperators, the Quebec SSS Council is self-mandated to promote the development of shortsea shipping in Quebec and between Quebec and the rest of North America. The Council aims to support development of Québec-based shortsea shipping services by providing information and expertise and by promoting marine transport's integration into domestic and continental supply chains.

In the Council's first few meetings, it defined the action and communications plans presented in this newsletter.

Shortsea shipping definition: Shortsea shipping is a multimodal transportation concept involving inland marine cargo and passenger transport without ocean crossings, i.e., within lakes and river systems and along coastlines.

Reminder Quebec Shortsea Shipping Council creation

The Quebec Shortsea Shipping Council was created in the wake of the Quebec government's Marine Transportation Policy and the Marine Industry Forum. In 2003, a report adopted by the Forum recommended establishing a permanent Shortsea Shipping Council coordinated by St. Lawrence Shippoperators.
